PFAS Remark :

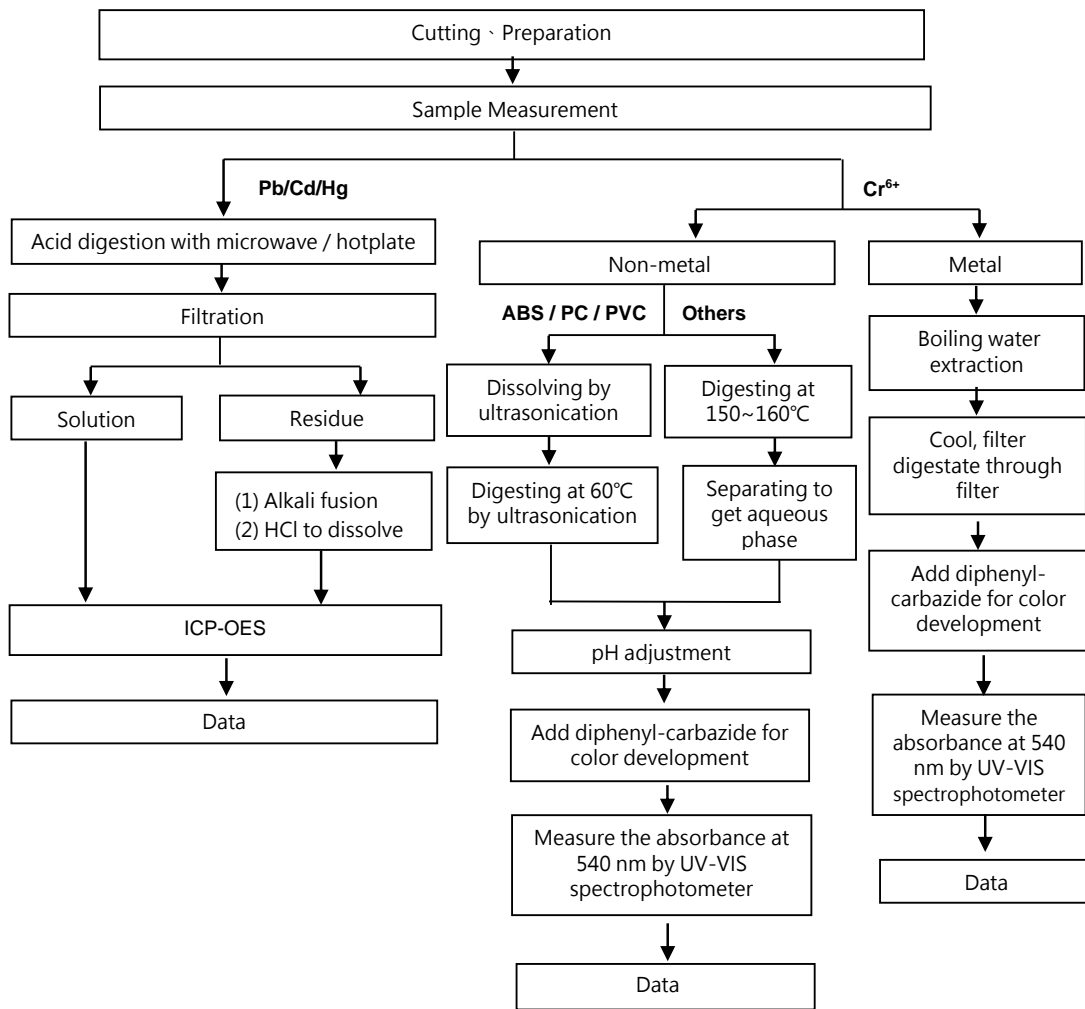

However, PFAS acid and its salts with the same carbon number group have the same specific structure that can be identified. The tested results of the analyzed specific structure cannot be distinguished to identify the contribution from PFAS acid or its salts. Therefore, the tested results display the sum of concentrations of PFAS acids and its salts with the same carbon number group. 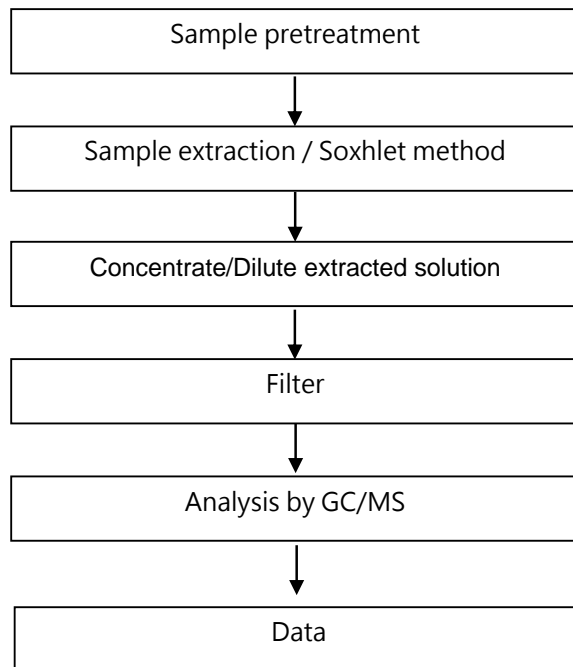

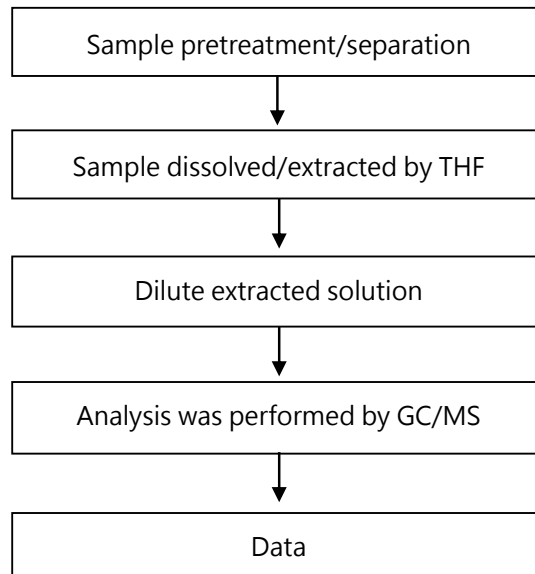
PBB/PBDE analytical FLOW CHART

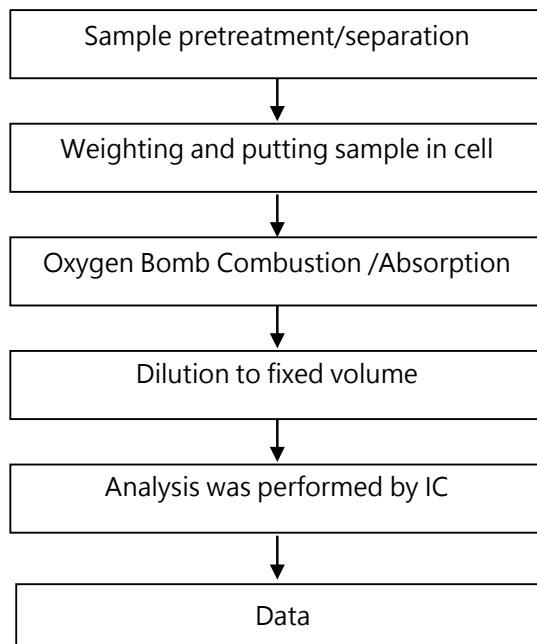

Analytical flow chart of Halogen

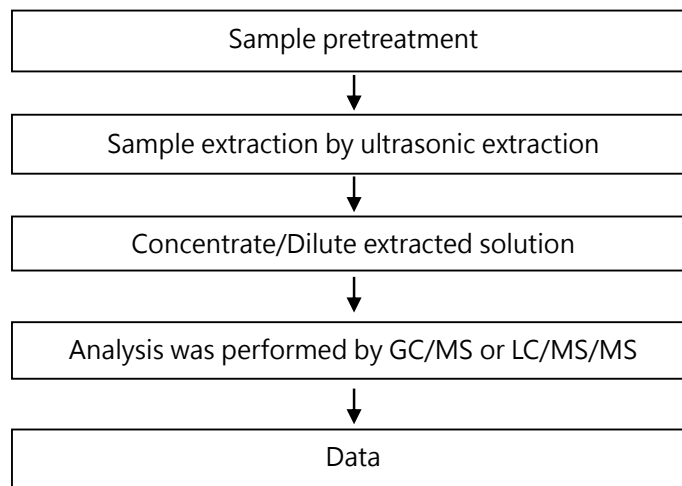

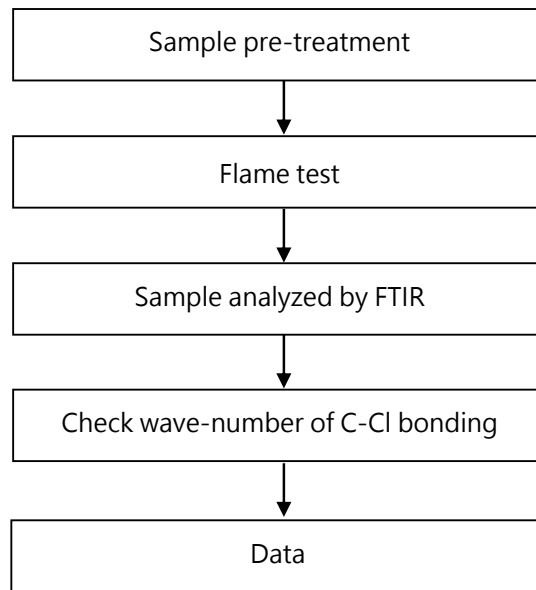
