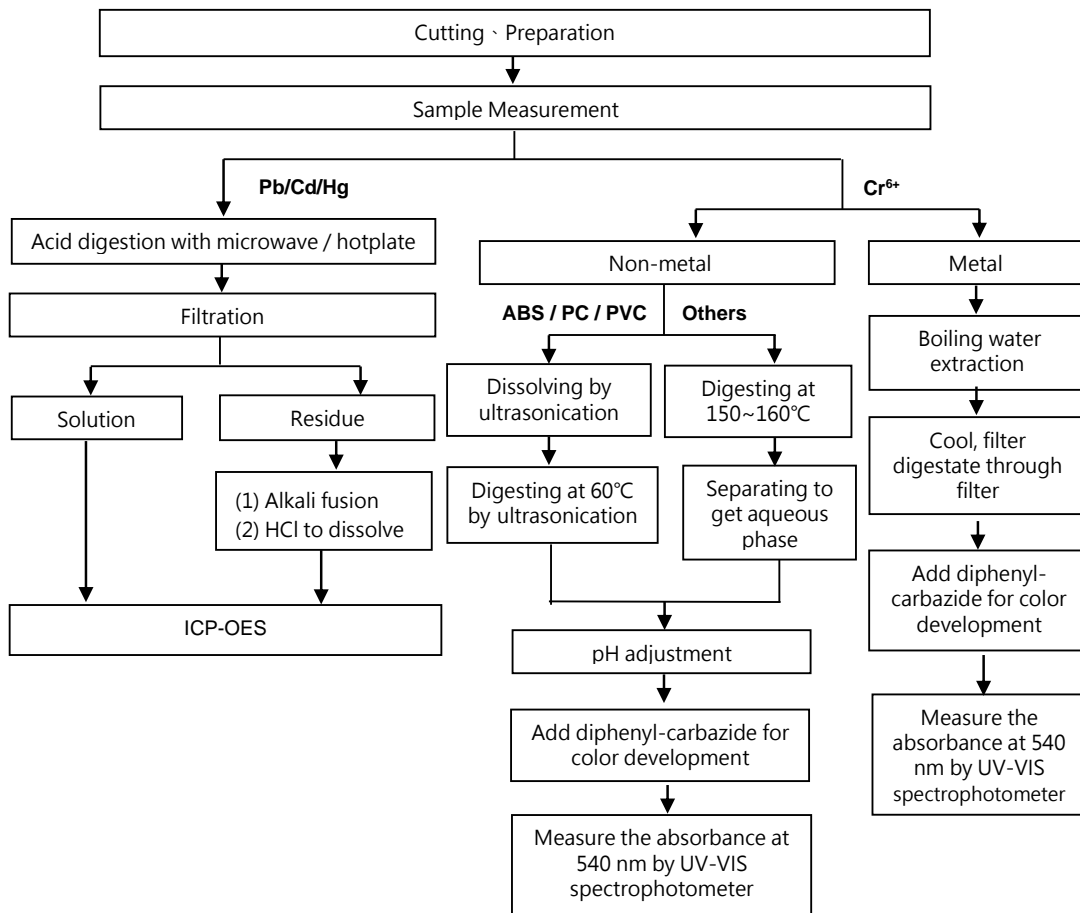

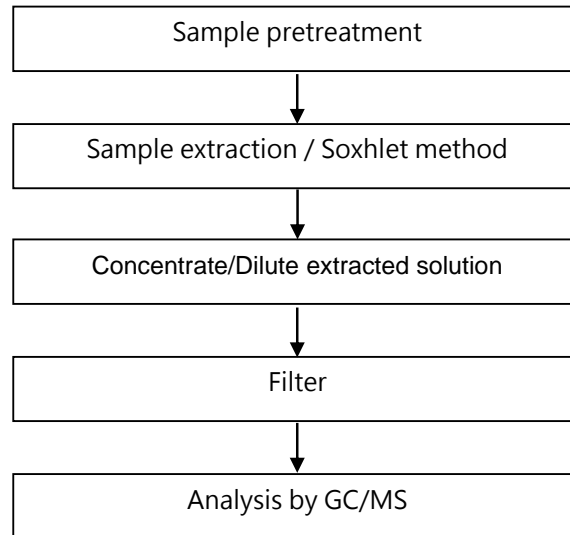

PBB/PBDE analytical FLOW CHART



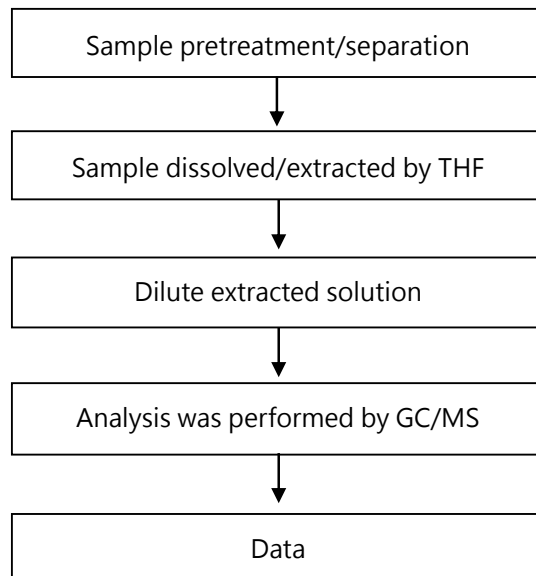

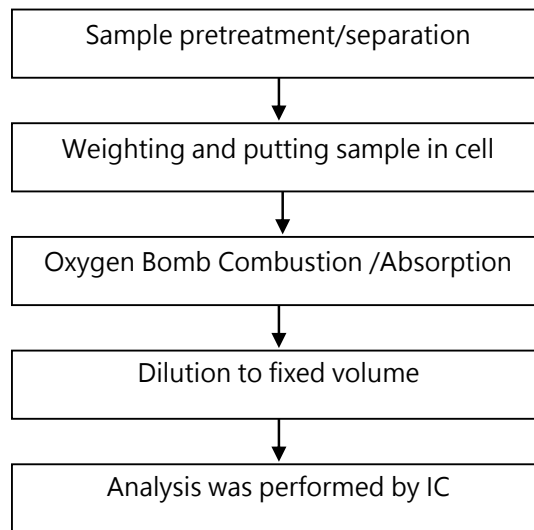
Analytical flow chart of phthalate content

Analytical flow chart of Halogen

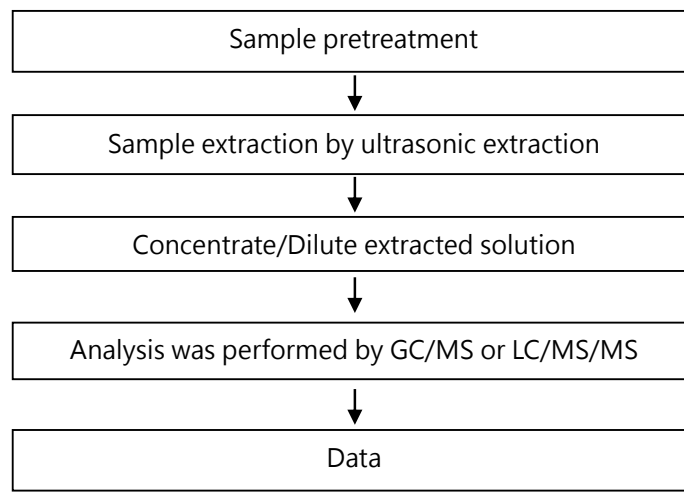

Analytical flow chart – PFAS (including PFOA/PFOS/its related compound, etc.)

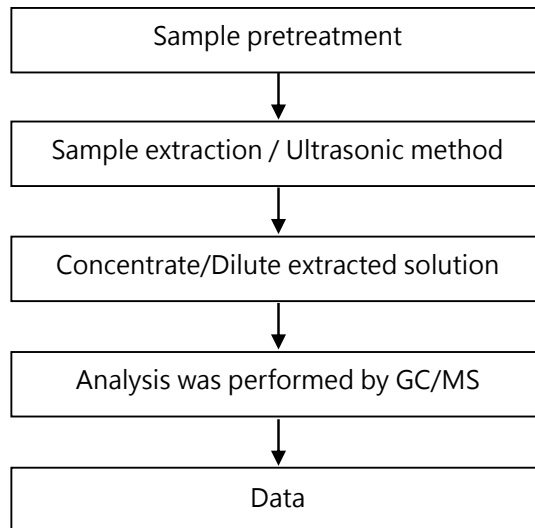

Analytical flow chart of Dimethyl Fumarate

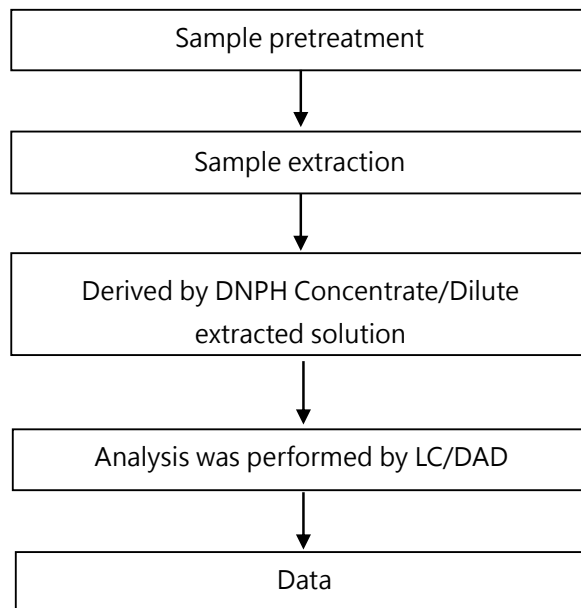

Analytical flow chart - Formaldehyde

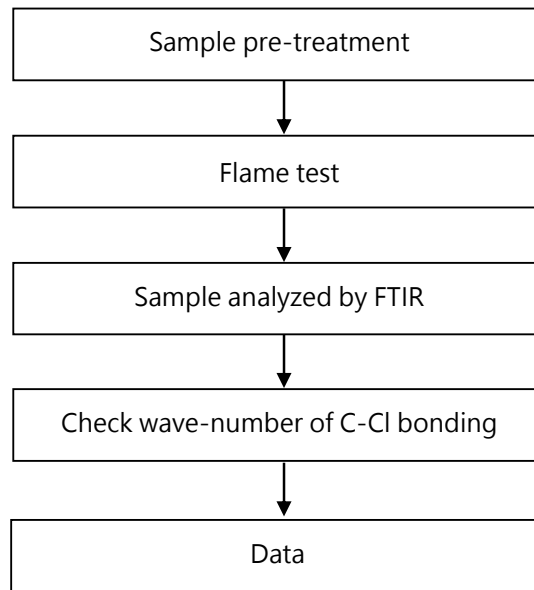
